

# Route 66 Pecan & Music Festival

## Rules, Regulations and Contract for Exhibitor Space

1. Please see application for show dates, times and booth details.
2. In the event of cancellations or interruptions of the show due to fire, strike, government regulations, act of God, or other cause beyond control, the committee shall determine if it's possible to reschedule the show and/or the equitable base for refund is any such portions of the amount paid is possible after considering expenditures and commitments already made.
3. The Festival Committee reserves the right to make final decisions as to whom and what products my exhibit at the show. Committee also reserves the right to assign all exhibitor locations and exhibitors are required to exhibit during show hours.
4. It is agreed that the exhibitor shall make no claim of any kind against the Festival and shall indemnify and hold harmless The Nut House LLC, sponsors, sponsoring organizations, board members, officers, employees, committee members of any such organization, authorized subsidiaries or authorized sub-contractors. Under no circumstances will these organizations be responsible for loss, damage, and destruction, theft of any merchandise, displays or goods of the exhibitors or injury to exhibitor or employees while attending the show. Also, it is expressly understood there can be no claim for damage of any kind to the exhibitor's business due to any circumstances that develop from the show.
5. All property of the exhibitor remains under the custody and control of the exhibitor, subject to the rules and regulations of the show. Exhibitors should not leave merchandise unattended during show hours and especially during move-in and move-out times. It is suggested that you contact your insurance agent regarding your coverage. Management is not responsible for loss. Building will generally be locked and secure until one hour before the show opens and one hour after close. All display unit and supplies must be provided by the exhibitor including tables, display shelves, etc. For inside booths, display units and supplies must be designed for indoors and must be contained within the booth dimensions.
6. Each exhibitor must know and comply with all laws, ordinance and regulations pertaining to health, fire, and public safety while participating in the show. All aisles and designated emergency exits must be kept clear at all times. Your area must remain neat and clean during the show. At the close of the show put your trash in proper receptacles.
7. The use of projectors, VCRs and DVDs is allowed as long as the volume is controlled. Use of microphones/amplification is not allowed.
8. No refunds.
9. Sales Tax (6.33%) **must** be collected. ***If you do not have a sales tax permit, taxes must be paid to The Nut House. If you have a Sales Tax Permit, please include a copy with your payment.***
